Parental Responsibility – If the parents of the child are married to each other at the time of birth, or they have jointly adopted the child, then they would both have parental responsibility. They do not lose this if they divorce. With unmarried parents, a mother always has parental responsibility but a father, however, has this responsibility only if he is married to the mother when the child is born or has acquired legal responsibility through another route.

Legal Contact – This means who legally has contact with the child whether they have parental responsibility or not. This is usually through a court order, e.g. residency, contact or care orders or it can be because the parent has re-married. If a court order is in place, please provide us with a copy.
